



Terms & Conditions:

1. The Interested parties shall submit in a sealed envelope, super-scripted with the words "**QUOTATION FOR DISPOSAL OF OBSOLETE DEPARTMENTAL VEHICLE**".
2. A Public Auction will also be held on 03.03.2026 at 11.00 AM at the Kemminje Office for each vehicle. Those who have submitted their sealed tender scan only participate in the Public Auction. The sealed tenders received, shall thereafter be opened and the highest bid from either the public auction OR the sealed tender will be considered for finalizing the successful bidder.
3. **The bid amount for each vehicle (excluding GST and other taxes) shall separately be indicated in the quotation.**
4. **The quotations below the reserved price/minimum scrap value will not be accepted.**
5. The EMD should be deposited along with the Tender in the form of DD/ Banker's cheques /NEFT-Account No.54017800123 in favor of ICAR Unit, DCR, Puttur (IFSC Code. SBIN0040152) drawn on SBI, Puttur or any other Nationalized bank, before participation in the auction. **Tender without EMD will not be accepted.**
6. Sealed Quotations will be opened in the presence bidder during the working hours in presence of bidders or their authorized representatives.
7. All taxes shall be paid by the bidders as per the rates applicable with intimation to the Commissionerate.
8. The bidders may inspect the staff car on the dates indicated above and satisfy themselves about the staff car they are bidding for.
9. The Earnest Money Deposit of the successful bidder shall be adjusted in the bid forthwith. The EMD of unsuccessful bidders shall be returned within one month from the auction date, without any interest.
10. Each vehicle shall be handed over to the bidder offering the highest rate for that vehicle, on deposit of the quoted amount and after codal formalities.
11. The vehicles to be scrapped shall be taken by the successful bidder at their own cost within (5 five) working days after depositing the bid amount and the Commissionerate will not owe any responsibility for transfer of the vehicles.
12. The successful bidder has to make full balance payment in the form of DD/Banker' scheques /NEFT-Account No. 54017800123 in favor of ICAR-DCR Unit, Puttur (IFSC Code SBIN0040152) drawn on SBI, Puttur or any other Nationalized bank payable before participation in the auction within working days oft hereceipt of the communication to this effect from this Office, failing which the offer will be cancelled and EMD shall stand forfeited.
13. The successful bidder will have to take delivery of the vehicle within five working days of acceptance of this bid after making the payment of the quoted amount (EMD amount will be adjusted with the quoted value) and submission of affidavit, failing which the successfully bidder will forfeit his right over the vehicle and process will be initiated for handing over the vehicle to the second lowest bidder or cancellation of the bid process. In both the events earnest money will be forfeited without any notice in this regard.

14. An affidavit regarding scraping of vehicle from the First Class Magistrate will have to be given, before taking possession of the vehicle and a letter will be sent to the Transport Authority to cancel the registration of the said vehicles.
15. The vehicle will be disposed of on "**as is where is basis**". The purchaser will be responsible for future legal matters whatsoever, pertaining to the vehicle after taking delivery.
16. The bidder will not be allowed to withdraw their bids, under any circumstances; otherwise, their Earnest Money will be forfeited.
17. Director, DCR reserves the right to accept or reject any or all tenders without assigning any reason.
