Terms & Conditions:

1. The trees can be inspected between 10 AM to 5.00 PM with permission from Scientist In charge, farm Kemminje / Farm Superintendent Kemminje
2. The cashew trees should be cut at ground level.
3. Tender value needs to be remitted immediately in the confirmation of the auction
4. Successful bidder should pay all the forest department taxes /KST etc based on the total sales value of cashew logs. The forest department tax has to be remitted to the forest department as per the guidelines of the same department before lifting the materials from the site.
5. Transporting permission must be obtained by the successful bidder before the commencement of clearing the site and transporting the stalked materials.
6. No implements or transport facilities will be provided by this Directorate.
7. While cutting & removing the trees, care must be taken to not damage Directorate's property.
8. The cutting and transport should be completed within 15 days of receipt of confirmation order.
9. In case the successful bidder fails to complete the work satisfactorily within the stipulated time, the Security Deposit amount withheld will be liable to be forfeited and no correspondence will be entertained in this regard.
11. The director of this director reserves the full right to accept or reject the offered rate without assigning any reason therefore and his decision will be final.
12. A sum of Rs. 2,000/- is to be remitted as EMD (refundable without interest) by DD/ Banker's cheques in favor of ICAR - DCR Unit, Puttur (IFSC Code SBIN0040152) drawn on SBI, Puttur or any other Nationalized bank payable before participation in the auction. **Tender without EMD as above will not be accepted.**
